    - Lag to getting regulations updated was because of change in process by Law Department and Department of Legislative Reference, which has now been completed.
    - ii. Will work to complete full board before completing regulations
    - iii. Will release a timeline early next year.
  - b. Drop Fees and Receipts.
    - i. There has been an increase in complaints around drop fees.
    - ii. Chair reiterates Title 21 Subtitle 10A Section 5 of Maryland Law
      - "Repossession by owner prior to removal to storage facility. -- Before a vehicle is removed from a parking lot, a tower who possesses the vehicle shall release the vehicle to the owner or an agent of the owner:
        - (1) If the owner or agent requests that the tower release the vehicle;
        - (2) If the vehicle can be driven under its own power;
        - (3) Whether or not the vehicle has been lifted off the ground; and
        - (4) If the owner or agent pays a drop fee to the tower in an amount not exceeding 50% of the cost of a full tow"
    - iii. Chair Braxton reiterates the importance of receipts.
  - c. Membership
    - i. There will be an application that should be released early next year for Tow Board Membership
    - ii. Looking to fill membership for Industry, Citizen at Large, and Property Management Members
    - iii. All new members will be required to live or operate a business in the City.
    - iv. All new members will have to go through executive nomination process and complete annual financial disclosures.
