## Possible Structure of the LCAB

Specific Subcommittees to Address Various Aspects of Local Control in Baltimore City

"The Advisory Board shall study the potential issues related to the transfer of control of the Police Department of Baltimore City from the State to the City, including:

- *implementation of the ongoing consent decree;*
- management of the Police Department;
- the transfer of personnel;
- different models of local control of the Police Department;
- financial impacts of local control, including liability issues; and
- the details of a potential charter amendment to assume control of the Police Department."

## High-Level Overviews-Models of Local Control

Traditional Local Control Board of Police Commissioners/Supervisors Hybrid Model Customized for Baltimore

Each of these models will require further research and community engagement.

# High-Level Overviews-Traditional Local Control

Traditional Local Control

Under this model, the state would transfer total control to the local jurisdiction.

**Composition:** Local Executive; Police Executive; Local Legislative Body

Appointment: The Police Executive is appointed by the Local Executive and confirmed by the Local Legislative Body. The Local Executive may terminate the employment of the Police Executive.

**Scope of Authority:** The Local Executive controls the operations, policy, and budget of the police department. The Local Legislative Body may as appropriate within the bounds of the jurisdiction's charter mandate certain policy changes for the Department.

### High-Level Overviews-Board of Police Commissioners

#### **Board of Police Commissioners/Supervisors**

Under this model, the Local Executive maintains hire and fire authority of the Police Executive and policy management is transferred to an appointed (and Legislatively confirmed) Board.

**Composition**: Boards of Commissioners or Supervisors are usually comprised of several civilian appointees and a handful of full-time staff.

**Appointment:** The Board of Commissioners or Supervisors and the Police Executive are appointed by the Local Executive and confirmed by the Legislative Body. The full time staff are typically selected by the Local Executive and confirmed by the Board.

**Scope of Authority:** Though many jurisdictions use this model specifically to focus on internal investigations and police accountability, several also use this model to govern departmental policy. In the policy specific model, the Board is responsible for researching and establishing departmental policy while the Chief of Police manages the day-to-day operations of the department. In some jurisdictions, the Board and staff of the Board also develop the Department's budget proposal.

## High-Level Overviews-Hybrid Model

### Hybrid Model Customized for Baltimore

Due to the requirements of Baltimore's Consent Decree, the City may pursue a model where the Local Executive retains "veto" power over certain aspects of departmental policy as set by the Board of Commissioners in order to remain in compliance with the consent decree or other applicable federal, state, or local law.
