 Human Resources, Law Department and Baltimore City Police Department will be the best
 experts dedicated to that particular task at a later date.
- No committees are needed regarding the consent decree or financial impacts as previous presentations have noted there will be no impacts on those functions.
- LCAB is considering moving meetings to Zoom to better accommodate people and technology.

Timeline

- Question as to whether the change in the primary date would have any implications on the charter amendment timeline – answer was no, the ballot submission date for the State Board of Elections remains August 5th for the November General Elections.
