I. Roll Call

II. Opening Remarks - Jim Campbell & Olivia Campbell The Co-chairs thanked the Commissioners for attending the meeting and continuing to support the efforts to provide resources to the older adults in Baltimore City.

III. Approval of January Minutes - Commission Members

The January minutes were approved with two additions:

- Commissioner Johnson advised that the Zeta Center's full name is the Zeta Center for Healthy and Active Aging.
- Commissioner Cudjoe said that his employment should include his association with Johns Hopkins Home Based Medicine.

IV. COVID-19 Update - Kendra McDow, Chief Medical Officer, BCHD

Dr. McDow provided an overview of the status of the COVID-19 pandemic in Baltimore City and the Health Department's response to it (see attached PowerPoint). Extensive efforts to vaccinate older adults in the City have been successful. For Baltimore residents age 60 and over:

- 86% have received their first or single dose.
- 82% are fully vaccinated.
- 73% of those eligible have received a booster.

Dr. McDow and the Division of Aging staff provided information on initiatives to provide access to vaccinations including senior housing vaccination clinics and vaccinations for the homebound. The Division continues to response to needs for service coordination through Maryland Access Point and for food, through several meal and food box programs, administered by the Bureau of Community Services.

V. Area Agency on Aging Director Update - Deputy Commissioner Tan

Deputy Commissioner Tan provided some updates on Baltimore City's American Recovery Plan Act (ARPA) funding.

VI. Legislative Updates - Jim Macgill

Mr. Macgill provided an update on Maryland General Assembly bills that the Advocacy Committee is tracking, and on which it is considering submitting testimony. He identified six categories of bills and some of the key issues these bills are addressing.

- Expansion of existing services: These include Medicaid coverage of dental care for adults, expansion of home and community-based Medicaid Waivers and expanded eligibility of the State supplemental SNAP benefit for older adults.
- Long term care: Several bills address quality of care and workforce issues within nursing homes, assisted living and residential service agencies.
- Protection of the vulnerable: The major bill in this area would establish of a vulnerable adult registry.
- Insurance regulation: Bills address modification of Open Enrollment periods, and making electronic advance directives available to participants in insurance plans.
- Tax benefits: There are several bills providing tax reductions and/or benefits for older Marylanders.
- Other: There are cross-filed bills to establish minimum qualifications for the Maryland Secretary of Aging.

VIII. Updates from Commissioners
